2. Preparing the timeware® 6+ system

2.1 Inform the customer that their timeware® 6+ system will no longer be collecting data from the terminals, but that the terminals will be storing all bookings in preparation for the timeware® Professional 2012 system.

2.2 Go to the timeware® training site: www.timeware.tv and click on the following link:

2.3 Search for 'm/01/015' (Stopping the services), and follow the notes.

2.4 Next, search for 'm/01/004' (Backing up the SQL databases), and follow the notes.

2.5 Next, print a copy of the 'Holiday Entitlement' report in preparation for step 5.

2.6 Next, search for 'm/01/022' (Uninstalling the services), and follow the notes.

2.7 Finally, uninstall the timeware® 6+ system.



Once the above steps have been completed, the timeware® 6+ system will be prepared for converting to timeware® Professional 2012.
